An Interreg Mechanism for Promoting Active Communities and Territories

IMPACT is a two-year European Commission-funded initiative to strengthen community-led local development (CLLD) in cross-border regions.

The challenge

Border regions often underperform compared to non-border regions

In 2023, unemployment was around 6% higher in border regions than in non-border ones ([OECD, 2024](#)).

In 2021, GDP per capita in EU border regions stood at only 86% of the EU average ([OECD, 2024](#)).

Structural barriers hold back cross-border development

Legislative, administrative and language differences raise costs for firms and limit labour mobility.

Limited cross-border co-operation can strain investment, limit public service delivery and reduce effective responses to emergencies.

Community-led local development (CLLD) can help meet cross-border challenges

- Despite its wide use across the EU, including in the [LEADER programme](#), **CLLD remains rarely applied in cross-border contexts, pointing to significant untapped potential.**
- Addressing cross-border challenges, such as limited access to healthcare and slow economic development, **often requires local solutions designed and delivered through co-ordinated action** on all sides of a shared border.
- **CLLD is a proven, place-based and participatory tool that helps mobilise actors on all sides of a shared border** and translate common priorities into tangible projects.

About the 2026-2027 IMPACT project

IMPACT will **strengthen CLLD in cross-border regions across the EU and in select neighbouring countries** by supporting local cross-border partnerships in the design of joint, place-based strategies, with the ultimate goal of improving resident well-being.

Main objectives

- 1 Support 30 pilot cross-border regions strengthen governance partnerships and adopt joint CLLD strategies.**
- 2 Generate sustained support from Interreg programmes for community-led cross-border development.**

What will the 30 pilot cross-border regions gain through IMPACT?



Tailored expert support to design and adopt a practical cross-border CLLD strategy.



Access to **peer learning and exchange** among pilot territories, Interreg programmes and other relevant actors.



Advice on: 1) **translating the CLLD strategies into concrete projects** and 2) **mobilising project funding**.

The project will also develop **practical tools, guidance and recommendations that can be used by non-pilot cross-border territories** and other actors interested in supporting community-led cross-border development.

How to engage with IMPACT

Apply as a pilot cross-border region

- A **first call for applications will be launched in February 2026**. Two additional calls are planned for April and June 2026.
- In total, up to **30 cross-border regions** will be selected.
- The calls are open to **regional and local institutions/organisations** with a legal entity in border regions (e.g. local governments, tourism offices, LAGs, EGTCs).

- Experts selected by the OECD will **provide training and coaching for the design of cross-border CLLD strategies**.
- **Experts and regions will be matched** based on expertise, language skills and availability.

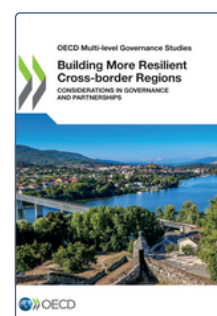
